Petition Progress

Many thanks to those members who have signed our petition asking the Council for some parking spaces to be removed from Regency Square and replaced with resident spaces in the car park. We have 54 signatures so far.

Thanks also to those who commented on the idea. Here's a summary of some of things they said:

- The simplest solution to the car park queuing problem would be for wardens to take action when drivers who are queuing block the road.
- Would resident spaces in the car park be reserved? Would residents have to queue at busy times to get to them?
- What is the point of removing parking spaces from the east side as well as the west side?
- Remove all paid spaces outside the car park leaving above ground parking for residents only.

The committee did consider various points, including most of these, before finalising the wording of the petition. Inevitably the wording reflects a compromise between differing views and will never please everyone completely.

More Signatures Needed

The signatures we have obtained so far are a good start but it's probably not enough to show the Council that there is strong support for our ideas.

If you support the scheme but haven't sent in your signature yet, please do it as soon as possible. A further copy of the petition is enclosed.

If you can persuade other people who live or work in the area to sign, please do.

Meanwhile we are planning to distribute more copies to non-members.

If at first ...

The war memorial in Regency Square is once again shrouded in scaffolding.



There is still no clear explanation of why paint started peeling off the metal plaques almost as soon as it was dry. However, there is now agreement amongst all concerned that

something is not right.

So the contractors who did the original job are going to put it right at their own expense, but not before they have consulted the Council's conservation officer and the War Memorials Trust about exactly what needs to be done.

They say it will be a couple of months before the memorial will be visible again.

Look out for otters?

Operation Otter is the code name for the police security operation to ensure the safety of the Labour Party Conference later in the summer.

The area around the Brighton Centre, and the Grand and Metropole Hotels will once again become a secure island site. Those who live on the island, such as residents of Metropole Court, will need a pass to get in and out. The security measures will be in place from September 27^{th} to October 1^{st} .

Before then the police will be visiting addresses surrounding the island site to check the identity of people living nearby. If you get a visit, don't forget to ask to see an identity card.

Trade Waste

It's a never ending battle to keep the pavements free of trade waste bins.

For months we have been asking the Council to take action over bins that block the pavement in the north west corner of Clarence Square, opposite the betting shop. At last we have had a response.

One of the offending bins has now been moved into a nearby private gated area. The other is to be replaced by a new, smaller bin, which will be located so that it doesn't block the footpath. So that is some improvement, but it still means that trade waste is stored in a public space.

Meanwhile down at the bottom of Queensbury Mews there is a blue trade waste bin which blocks the pavement, except when the enforcement officer comes to look; at that time it always seems to be on the private forecourt of the fish and chip restaurant. The enforcement officer is monitoring the situation.

The view from the pier

Three members of the Society committee visited the West Pier recently. We met Glynn Jones, chairman of the West Pier Trust together with Geoff Lockwood and Rachel Clark, who manage it.

Our aim was to find out what is happening. The pier has recently been fenced off because of concern about safety. The Trust has been advised that the Rock Shop is unstable. Some of the railings may also be unsafe. The result is that the whole site now looks a mess, though there are plans to improve it a bit by putting up some display boards.

Longer term prospects for the site seem to be uncertain: the i360 project is on hold because it has not been possible to raise all the finance needed. We were assured that Marks Barfield, the architects behind the scheme, are still fully committed. Sections of the tower have already been made in Holland and some drilling work is expected to start on site in September.

We asked how long the Trust is going to wait for the project to get off the ground. The answer seems to be that everything depends on the i360. There is no plan B at present. However, if nothing happens by the end of the year, the Trust Board will review its strategy.

What was clear from the meeting was that the people running the Trust are still confident that the i360 will be built, once the recession starts to ease. On the other hand they can't give us any idea of how much longer the blight now affecting our bit of the seafront will continue.

- 1 remove the parking spaces adjacent to the green on the west side of Regency Square, in order to prevent tailbacks, which occur when the car park is full and which disrupt through traffic;
- 2 remove the corresponding spaces on the east side of the square in order to improve the appearance of the square, which has too many parked vehicles;
- 3 replace the resident spaces lost as a result of these changes, and create some additional new resident spaces, inside the Regency Square car park, thus increasing the number of resident spaces available and making better use of the car park, which is often largely empty;
- 4 take steps to improve the appearance and security of the Regency Square car park so that more people will use it.

LATE SUMMER OUTING SUNDAY 23RD AUGUST 2009 WREST PARK AND THE DE GREY MAUSOLEUM

After leaving Brighton we will travel to the village of Silsoe in Bedfordshire where we have lunch at the Star and Garter, a 16th century Inn.

After lunch we will visit Wrest Park, owned by English Heritage. The site was the home of the De Grey family since the 13th century until 1917. The gardens are celebrated for their rare survival of a formal early 18th century layout of wooded walks and canals, centred on the architectural highlight of the pavilion designed by Thomas Archer in 1710. Subsequent generations added garden buildings such as the Bath House and the Chinese Pavilion, valuing the special atmosphere of the established gardens even when more fashionable landscapers would have swept it away. Lancelot "Capability" Brown was employed to enhance the gardens doing little more than nibbling at the edges of the earlier 18th century landscape.

The old manor house was demolished when the present house was completed by 1834. This .was designed by Thomas Earl de Grey, an enthusiast for 18th century French architecture. It is set further north than the site of the old house, and new formal gardens were laid out between the mansion and the woodland garden. The Orangery, Italian garden and Parterre with magnificent lead statues date from the 19th century. The house is one of only 3 in this country modelled after the design of a French Chateau. The stile of the gardens was inspired from those at Versailles and the Loire Valley.

The house is now used as an agricultural college and hopefully we will be able to see the interior with its splendid painted ceilings and other architectural features and paintings. This will be subject to weather the house was in use for a corporate function the day before. The tour of the gardens is by a self-guided audiotape.

After seeing Wrest Park we will go to see the De Grey Mausoleum in the nearby village of Flitton, which is among the largest sepulchral chapels attached to any English church. This cruciform mausoleum houses a remarkable sequence of 17 sculpted and effigied monuments, spanning nearly 3 centuries (1615-1899), to the De Grey family from the Park.

Our tour guide Michael Robins (01273 773052) will accompany the outing.
