Over the year our activities have included the following:

ACTION.

- negotiations with the Council over the fencing of part of Regency Square as a dog free area erection of the fencing is due to start this month.
- discussions with the Police over exhibition traffic in St Margaret's Place and Queensbury Mews this is a continuing problem. There seems little the Police can do but residents are suffering considerable nuisence. We are keeping the situation under review. Please let the Chairman know if you have any particular problems we need examples of the nuisence if we are going to take any more action. We are also now raising with the Metropole Hotel the question of rubbish left in the street by exhibitors.
- persuading the Council to provide litter bins in Regency Square

ACTIVITIES

- social evenings at the Hotel George IV and the Portland House Hotel
- a coach outing for children and senior citizens
- a firework party on November the fifth we have already ordered our firewoks for next November when we plan to have an even better display
- a bazzar and jumble sale to raise funds for the Society.
- support for local activities the West Pier Society, Brighton Little Theatre Company and The Evening Argus Christmas Appeal.

We hope to do even more in the coming year. But we need more Committee members. We also need a new Secretary: Carol Clipsham has helped get the Society off to a good start as its first Secretary but unfortunately she now feels she must step down because of other committmemnts.
