# TRAFFIC SENSE

Success at last! After many months of complaining to the police and the Council it seems we have succeeded in changing the carpark entrance traffic layout.

Previously cars could enter either from the western side of the Square or from Preston Street. At busy times queues would tail back into Preston Street blocking it and stopping trafic from getting into the Square.

Now, as suggested by the Society, the entrance from Preston Street has been blocked off. Traffic from Preston Street has to go right round the Square to join the other queue. This is a fairer system for motorists who have only one queue to join. It also reduces the traffic chaos at the top of the Square.

## CAR PAPK REPAIRS


The underground car park in Regency Square needs £25,000 worth of repairs. The purpose of the work will be to repair damage caused by the expansion and contraction of the deck.

However, because of the economic climate it is unlikely that the work will start before 1982. When it does start it should take about three months but should not create much disruption: the car park will continue to operate normally except for the closure of a few parking bays and it will not be necessary to close the road.

What's happening to the West Pier? Well, it's still standing in the sea opposite the war memorial.

You will remember that a businessman called Alan Hawes had applied for planning permission to build a funfair on the landward end. In spite of protests - including quite a few from members of this Society - the Council granted outline planning permission, subject to Mr Hawes providing the necessary guarantees that the whole pier would be restored.

Since then Mr Hawes" Company has gone into liquidation and he is unlikely to continue to be involved with the Pier. However, the planning permission still exists. The Brighton West Pier Society Limited in its January newsletter is talking optimistically about other companies interested in taking on the scheme.

Meanwhile the Council has apparently not yet set the wheels in motion to demolish the Pier though they had said they would if a scheme for saving it was not well under way by the end of 1980.

The Pier is a listed building. If the Council did decide to demolish it there would be a public enquiry at which local people who want to see it saved would no doubt fight very strongly to persuade the Secretary or State to prevent demolition.

As soon as any new moves are made to either demolish or develop the Pier they will need to be debated by this Society to decide if we would want to support or oppose them. Your committee is keeping the situation under review.

# REGENCY SQUARE COLOUR SCHEME

It's official. If you live in 2 - 46 or 51 - 66 Regency Square or in 131 Kings Road you are now the subject of an official "Direction" issued by Brighton Borough Council.

The direction is that if you want to paint the front of your house in any colours other than exactly those it is now you will need planning permission. And you will only get planning permission if you agree to use the standard colours approved by the Council which are:

All external walls, surfaces, pipeworg, gutters, downpipes etc and including all rendering and boundary walls and canopies and posts thereto, where already paitned - colour BS 10 C 31 - finish gloss/smooth masonary paint.

All woodwork window frames sashes, glazing bars, door frames etc - colour BS 10 C 31 - finish gloss.

All architectural ironwork, gates,railings, balconies etc but excluding posts to canopies - black gloss.

# front and basement doors colour optional - finish gloss.

BS 10 C 31 is the British Standard number for a particular shade of cream.

Presumably if you live in 46a - 50 Regency Square the Council aren't interested in the colour of your home.
