### Regency Mews, 'Russell Square


The story so far: when Dutton Foreshaw Foreshaw closed their garage in Regency Mews they sold it to National Car Parks who tried to open a car park. Thanks to a major campain lead by the Society this was prevented, thus saving Russell Square from terrible traffic problems.

Next there was an attempt to develop the site as a skating rink. Again we opposed this on various grounds, including the traffic congestion it would cause.

All along the Society has pressed for residential development. Ideally the Council should take over this valuable site and use it for much needed town centre housing. But they say it would be too expensive.

Now there is a new planning application being considered for 3252 square metres of office accomodation with 39 parking places, 17 retirement flats, warden maisonette and communal facilities with six parking places. The Society's committee has not yet considered the plans. They may be seen at the planning department,83 North Street.

Things are moving on the Pier, and not just the bits which keep falling off. A few months age a group of Department of the Environment officials visited the pier. There is now hope that the Department will meet the cost of urgent repair works and a major survey to determine the cost of full scale repairs.

The Brighton Trust will hold its AGM at the Grand Hotel at 3 pm on Sunday 5 February. Latest developments will be reported then and we will keep you informed infuture issues.

# Proposed Beach Childrens Play Area

Those who came on the Society outing to Eastbourne a few years ago will know that a playground of this kind is great for both visitors and locals. For a small charge children can enter and play as long as they like on the toys and in the paddling pool. Parents can sit in deck chairs and buy a cup of tea.

Brighton would benefit from a similar Playground. But it should not be provided by robbing the local community. That is what is proposed by fencing off half of our paddling pool.

The Council are proposing to spend £250,000 on developing this play area. Five sights have been considered and the parks Committee are considering enclosing an area including the putting green, half the paddling pool and the walkway on the sea side of the putting green and paddling pool.

The Society has approached the local Ward Councillors and asked them to try and prevent this scheme from going ahead. We are not against the play ground in principle, only against the location.

If the present BlackRock development does not go ahead this would be an ideal site for the play area. Failing this the gardens to the West of West Pier should be considered.

# A Broader View of Brighton.

Through our delegate to the Conservation Area Planning Committee and our affiliation to the Brighton Society we are keeping a watching brief on the major developments that are now taking place. These developments will change the character of our town.

## The Jubilee Site.

This is between Church Street and North Road and includes the Prince Regent Swimming Pool.
Planning permission is being given to build a skating rink, new library, offices and housing. We have opposed the demolition of the houses in North place and presseds for a reduction of office space and an increase in residential housing.

Station Site Development.
This delelopment covers 64 acres and the main feature is a bye pass relief road, diverting traffic from Preston Circus and running parallel to London Road re entering it at St. Peters Church.

The plans include extra shopping facilities, offices, housing and limited manufacturing space.

We have opposed the intention to build a large Super Market and Store and again pressed for less office space and increases residential houses.

# Sea Front Development

This will provide for the demolition of the Council premises adjacent to Plack Lion Square. Replacing this with a 200 bedroom Hotel and building Council Offices and a town square behind the hotel.

It was proposed to close this new town square without an outlet to the sea front. A compromise to leave a clear view and access under the hotel has been agreed.
