Following a suggestion from the Society, the Council has built a paved footpath across the lowest green of Regency Square. It is now possible to get to the car park exit without muddy feet.

The Brighton Mnetropole Hotel made "record profits" last year according to the report from its owners Lonrho.

The Beach Cafe by the boating pool may soon be opened up as an amusement arcade if a planning application at present before the Council is accepted.

GEORGE IV

The Hotel George IV occupies three fine houses at the top of Regency Square.

For many years it has done little business as a hotel. Its main contribution to the life in the area has been a night club in the basement. This has caused endless noise and disturbance.

The whole building is now closed. A planning application has been made for conversion to residential use.

The Council has a policy of opposing such changes. Their aim is to maintain the number of hotel bedrooms in the town centre. We have written to the Council encouraging them to allow a change of use in this case.

After talking to the architect involved with the proposed development we believe that the prospective developer is a reputable company which will convert the buildings well and save their crumbling facades.

It will be far better to have the bulldings put to good use as flats than for them to stand empty as a hotel no one wants to run, or worse still open up yet again as a night club.

FOCUS ON RUSSELL SQUARE

Russell Square has some beautiful houses in it. Now that the daffodils are out in the garden it should be ome of the nicest parts of the town.

Far from it. Russell Square is a mess!

THE CHURCHILL CENTRE HOTEL

In a prime position at the western end is the Churchill Centre Hotel. Some months ago the wall round the basement area was removed leaving a dangerous drop from the pavement. This has now been fenced off by the Council for safety reasons.

The result is that the whole pavement is blocked. Pedestrians are forced to walk into the road. The Society has complained to the Council about this. In replying the Borough secretive says that they regret the obstruction but feel it is preferable to "persons falling into the basement area".

They have served notice on the owners of the hotel requiring them to replace the wall. In fact they have offered a grant to pay for railings to be used matching the other houses. The owners have apparently undertaken to complete the work by October this year. It is a slow process!

We also wonder whether the hotel has anywhere to store bins. At present they seem to stack rubbish in the street at the side of the building.

DUTTON FORESHAW SITE

Walk round the square to the north from the Churchill Centre and you pass first the old Dutton Foreshaw garage entrance. The garage behind has been demolished. The site is now owned by a company Called Hargreaves Construction.

They have been resonsible for quite a bit of development in Brighton. They built the new British Telecom offices near Preston park and they are working at present on a big site in Dyke Road.

They have applied for permission to build offices on the Regency Mews site with some housing at the Russell Square end.

The previous owners had already won outline approval for offices with sheltered housing. This new scheme has replaced the sheltered housing with town houses. This is a backward step. The Society has always pressed for sone sheltered housing on the site.

Old people living alone need to be in the town centre so that they can still get around to the shops and other facilities. They can also benefit greatly from having their own home but with a resident warden neaby to help out if needed.

We think it is a great pity that this part of the plan has been dropped. We have also sent in detailed comments on other aspeces of the plans which will be the biggest development in our area for a decade or more.

Whatever plans are finally accepted they should improve the appearance of that corner of Russell Square.

21 - 23 RUSSELL SQUARE

Continue round the north side of the Square past some well kept property and you come face the face with numbers 21 to 23.

Number 21 is by far the worst eyesore in the square. Like the Churchill it has missing railings. These have been replaced with a rusty piece of scaffolding, which provides minimal safety. The facade is crumbling. The front steps are usually littered with bags of refuse.

What can be done ? It is hard to know how anyone can allow a beautiful building to fall into such a state. But if someone chooses to neglect their property in this way, what can their neighbours do ?

Numbers 22 and 23 are also in a sorry state. But we are pleased to report that there is a planning application in for conversion of number 23 to self contained flats. The house on the opposite corner has just been converted and looks very smart; let's hope that number 23 gets the same treatment.

NUMBER 46

The house on the southern corner of the square faces into Cannon Place. It has been empty for some time, work was started to convert it into flats. Then nothing happened for a while.

However, we have been in contact with the owner's representative who assured us that work will be continuing soon.

LITTER

"Litter" can mean a lot of things. People who leave cigarette boxes in the gutter are certainly guilty of it. And Russell square has its fair share of that.

It also has an unfair share of plastic bags full of household refuse which pleases no one except perhaps dogs. Maybe some larger litter bins at the end of the square would help. What do you think ?

If it is a case of litter to leave a cigarette box in the gutter, then what about people who park their cars on double yellow lines? This is happening more and more along the south side of the Square.

The roadway there is extremely narrow and has double yellow lines along the full length. It is completely unsuitable for parking. Once one car is there others seem to appear safety in numbers perhaps.

ON THE WAY UP ?

So that is Russell Square in Spring 1985. Like all Brighton's fine squares it has its ups and downs. Right now it is fairly low down but we are hopeful it will soon be on the way up. The Society will do all it can to help.


BETTER THAN 1000 WORDS!
