

Creeping Blackstuff

The tarmac footpaths which replaced the paving stones in Russell Square has now started to creep around Clarence Square.

It seems strange that in a conservation area, the Council can get away with using materials which are so obviously out of keeping with the surrounding historic buildings.

In the past we have been told that some parts of conservation areas are more special than others: that is why Regency Square still has paving stones. We are asking the Council to confirm that this policy still applies and that the blackstuff will not start to creep there as well.

Déjà Vu

One of the things which led to the formation of our Society was the problems which resulted when a late night drinking club opened in the basement of the former George IV Hotel in Regency Square.

Revellers leaving the club in the early hours regularly caused disturbances. Local people organised protests and gave evidence in court but all to no avail. The problem only went away when the club went out of business.

Part of the problem was that no one objected to the club when it first applied for planning permission and licensing approval.

The aim of those who formed the Society was that in future local people would have advance warning of such applications and would be able to voice their objections collectively if appropriate.

A report in the Argus a few weeks ago shows that the problem has not gone away:

"Neighbours are furious after a Brighton club was given permission to open until 2am six days a week."

The club is in St James Street and there are people living directly above it one of whom complained that "you can hear the bass constantly." Another neighbour said "When we bought the flat it was just a wine bar. We had no idea it would be turned into a night club."

Slipping into Chaos

We are entering the most chaotic period of the year as far as rubbish collection is concerned.

Following the two Easter bank holidays the "slip a day" system means that rubbish collection should move from Thursdays to Mondays.

And then there will be two more holidays in May each of which will result in a change of collection day.

The streets are already littered with rubbish put out on the wrong day. What a ridiculous system!

Cable is Coming - but not yet a while

The good thing about cable is that it offers the possibility of a wider choice of TV programmes and cheaper telephone calls.

The bad thing is that it will involve the pavements being dug up and unsightly junction boxes being located around the area.

We have been told by the Council that Nynex, the firm installing the cable, do not expect to do this area until "some time in 1994".

The Council's Planning Division will be consulted before any junction boxes are located in the Regency Conservation Area and the Conservation Areas Advisory Group, on which we are represented, will also be kept informed of developments.

One suggestion, which has been put to Nynex, is that the boxes could be located in basement areas rather than at street level.

Congratulations to Sussex Heights residents who have finally persuaded NCP to let them have keys to the door in Oueensbury Mews.



The Last Word on 32

In response to our recent comments on the design of the front windows of 32 Regency Square, one member has drawn our attention to a book called "The Englishman's Castle" by John Gloag.:

The window tax was repealed in 1851. The Victorians liked lots of windows, and improvements in glass manufacture accommodated this liking. Sash windows could now be glazed with single large panes of glass, so that the rectangular window opening, while still retaining the proportion of the double square, was divided into two parts only. These large panes of excellent glass let in more light, but windows lost the neat appearance which the white painted glazing bars had imparted to them in the Georgian age."

So it seems that the new windows that have been fitted, an example of which is illustrated here by committee member Diana Dunn, are correct copies of the originals

Council Employs Answerphone Machine to Combat Late Night Noise!

At the AGM there was a suggestion that the Council has an anti-noise patrol operating at night to deal with rowdy parties and other disturbances.

As far as we can discover this is not the case. The actual position is that if you are disturbed by noise you should phone Brighton 712717. Outside office hours you will get an answer machine: if you leave a message action will be taken the next working day.

The action, is likely to be legal rather than direct prevention. This means that if you are disturbed it is essential to make a written note of the date, time and nature of the noise.

What this seems to indicate is that nothing has changed yet as far as noise prevention is concerned: the Council can take action against persistent offenders but only by means of lengthy legal procedures.

We are planning a meeting with the Council Officer responsible for dealing with noise problems and will report any further information in the next newsletter.
