

# The Society's Year

# **Churchill Square**

The plans for Churchill Square were probably the biggest issue facing the Society over the past year.

As a result of Society comments, the developers changed their plans to include some improvements to the Cannon place facade of the site.

The Committee also informed the Council of the concern of local people about the potential impact of increased traffic. We were pleased to be reassured that the scheme would not result in the loss of any residents' spaces.

Many members were unhappy about the closure of Regency Road The Committee considered making a formal objection to the road closure, thus forcing a public enquiry. At a Society meeting members had a chance to meet a representative of the developers and to hear the views of our three local councillors. As a result it was decided that the loss of Regency Road was a price worth paying to see the re-development go ahead.

# Other Planning Issues

The committee has reviewed local planning applications and the Chairman has continued to represent the area at the Council's Conservation Areas Advisory Group (CAAG).

A complaint was made by the Society to the Local Government Ombudsman about the Council's handling of an application by the Castle Snooker club for extended opening hours. The Ombudsman investigated what had happened but came to the conclusion that the Council was not guilty of mal-administration.

The Society has continued to monitor the development of flats at 40-41 Castle Street. In spite of a requirement for rubbish storage at the back, it seems now that large amounts of rubbish are being stored in the street.

#### Rubbish

This has been the first year for quite some time that the committee's work has not been dominated by the issue of rubbish. The situation is still far from perfect but the Council's decision to abandon the system of changing collection days after each bank holiday has done much to reduce the amount of rubbish lying in the street. Extra collections at weekends also seem to be taking place.

## Parking

The Committee has complained to the police abut the lack of enforcement of parking restrictions.

We also commented on a proposal for an ambulance bay for the Regency Division of St John Ambulance. We supported the need for a bay but suggested that it should be located in Queensbury Mews rather than in front of houses in Regency Square. The Council eventually rejected both ideas and the ambulance still has no local parking place.

Businesses in Western Rd have started parking cars and putting rubbish on the pavement at the top of Cannon Place. This is unsightly and causes an obstruction for disabled people getting from the new disabled parking to the shops. We have raised the problem with the businesses concerned.

#### No Fireworks

The Society's first firework party was in 1979 and there has been one each year since until 1995 when we decided not to continue. We want to thank the members who have anonymously donated the fireworks for so many years.

#### Noise

The Compass pub in Clarence Square has been the cause of much disturbance to its neighbours in recent months because of loud music and rowdy customers. The Society has supported local residents in trying to get Council action. We had little success but are pleased to report that a change of licensee seems to have solved the problem.

## **Fund Raising**

The Society has set up a Regency Square Improvement Fund. The fund, which is held in a separate, interest earning account, currently stands at £2,325 and the new committee will need to start the job of deciding how it is to be used.

The Society also joined with other local groups in supporting the Council's successful bid for an Urban Regeneration Grant. A sum of about £7 million was awarded to the town and about £2 million will be spent in and around Regency Square. The Society will play a role in the consultation process that will lead to decisions on how it is to be used.

## **Social Activities**

It has been a busy social year. The AGM was well attended and was followed by interesting talk by John Roles on the old theatres and cinemas of Brighton.

A prize draw at the Beach hotel raised over £2,000 for the Improvement Fund. A silent Auction at the Regency Hotel added £237.

With help from Brighton Council we were again able to put a Christmas tree Regency Square. Committee members met for a Christmas drink in the Regency Tavern and were pleased to be joined by other members of the Society.

#### The Committee

Harold Lawson has now decided to stand down as chairman However, we are glad to report that he is standing for election as a committee member and has offered to continue to represent the Society at the Conservation Areas Advisory Group.

Society treasurer, Brian Smith has been nominated as chairman. At the time of going to press confirmation is still awaited of who is to be nominated as the new treasurer. Pat McCulloch is standing for re-election as Secretary

Kate Page has moved out of the area and has resigned as a committee member. She joined the

committee in March 1994 and her fellow members want to record their thanks for her support during the past two years.
