Bins on the move

We reported in the last issue that several large wheelie bins were parked on double yellow lines in Clarence Square.

They have now been moved back onto private land and the situation is being monitored.

Cannon Place bottleneck

Have you ever tried to drive up Cannon Place from the seafront when there's a queue into the Churchill Square car parks?

If so, you'll know that it's not a good idea. There is supposed to be a passing lane for through traffic to get past the queue. The trouble is, it very easily gets blocked. Then you're stuck in the queue. One member who lives in Chartwell Court had to wait twenty minutes the other day.

It's not right that residents should be denied access to their homes in this way. We are planning to ask the Council to look again for a solution to the problem.

One idea is that local residents with cars could be issued with a special pass allowing them to drive along Western Road and into the north side of Clarence Square. This route is not legal for most vehicles.

Passes would be needed by residents of Russell Square, Clarence Sq. / Gdns, Cannon Pl. and St. Margaret's Pl.

Ask an ecologist!

We are still trying to get information on the unfinished pruning of bushes in the north east corner of Regency Square.

We asked the Council parks department what was going on. They responded by asking us if we wanted them to complete the pruning or leave the bushes as they are now.

We then asked them if further pruning would have a detrimental effect on the local sparrow population.

The park ranger who is responsible for the square has done quite a bit of research. He has contacted the RSPB and the Council's own ecologist Matthew Thomas.

The general view seems to be that sparrows need thick cover so they can feel protected from predators. Hedges and bushes also provide food.

The high bushes in the square were cut right down to encourage them to grow thickly but at a lower level. This would prevent their use for undesirable human activity, while still providing cover. Obviously this removes some of the cover temporarily, but that is not a problem if there are other bushes nearby which have not been cut down.

We are waiting for Matthew Thomas to visit Regency Square later this month to clarify his advice on whether the remaining bushes should be pruned.

Once we know what he thinks we will need to make a decision on how to reply to the Council's original question – do we think the pruning should be completed?

Let us know your views.

BT pulls the plug

Take a last look at the phone boxes at the southern end of Regency Square. They won't be there much longer.

Not that they will be much missed. They have not been working for some time and are in a very sorry state.

So when we asked BT to tidy them up they said that they were not profitable and would therefore be removed. It's hardly surprising they are not profitable: they don't work.

Anyway, the decision has now been made: they will be gone in a few months – yes it will take several months!

If you need a phone box after that, the nearest will probably be in Western Road, either outside Primark or just before you get to Waitrose. There's also a payphone in the Metropole Hotel.

Counting Crimes

Latest figures from the police for our area suggest that burglaries from homes are increasing. This reflects a trend in central Brighton generally. So if you have accessible doors and windows, keep them secure!

The only other type of crime occurring in significant numbers is described as "rowdy behaviour". This covers things like shouting, fighting and being aggressive.

In the period from November to January there were no drug related offences reported in our area. Likewise for robbery, street drinking, begging and noise.

If this doesn't sound like the area you know and love, remember that these are the number of offences reported to the police. They haven't yet found a way to count crimes that are not reported!

No listing for the church

Our neighbours in the Montpelier and Clifton Hill Association were worried when they heard about a planning application to make further changes to French Church in Queensbury Mews. So they made an application for it to be listed.

The response from English Heritage is that while it is a "building of clear local interest", it is "not strong enough architecturally or historically in national terms to merit listing".

They also say that the building "has been converted to a dwelling in a manner that respects its integrity, with minimal external alteration to the visible elevations."

Our committee looked at the original application for further changes but did not make any objection.

Improving Regency Square

Two of our committee members are putting their heads together to produce a plan for improving the garden areas of Regency Square.

They will be looking at ideas such as new flower beds, wild flowers, additional benches and painting the railing. Maybe we can even install one of the West Pier relics that are currently on sale.

Where's the money coming from you ask. Good question! The Society certainly doesn't have enough money to do these sorts of things.

The idea at the moment is to decide what we would like to do and to find out how much it would cost. Then at least we'll know how much we would need to find to make the ideas a reality.
