# The Committee's Annual Report

## Improving the area

We started the year by circulating a questionnaire to everyone in the area to see what they thought of our ideas for improving Regency Square. We had 70 responses.

The proposals which won the most support were:

- new seats and removal of broken seats
- new path to car park entrances
- new flower bed in the top garden
- new litter bins

Good progress has been made. We now have two new benches, with plans for more and for repairs to the old broken ones.

A new flower bed has been dug in the top garden and planting will start shortly.

Redundant dog waste bins have been removed.

A gardening club has been set up which meets each Saturday at 11am for a couple of hours work. As a result the top garden is now much less overgrown. The club is open to everyone and is now looking at what needs doing in Russell and Clarence Squares.

We are hoping that the Regency Square railings can be painted in the next few months. There is also talk of "Phase 2" improvements in the gardens.

Many thanks to Duncan Cameron, Nigel Rose and Trix Webber for all their hard work on this project.

## The Heritage Board

Last year we were delighted to report that we had been awarded a grant of £2,200 for a heritage board in Regency Square.

Some progress has been made. The Council has given permission for the board to be located at the top of the square. We have also obtained permission to use a painting of the Square as it was in the 1820s.

However, there have been several problems along the way. We hope to complete this project soon.

### The West Pier site

There is still no sign of the i360 being built. The area of seafront owned by the West Pier Trust is falling into serious disrepair, including the former rock shop which is a grade 1 listed building.

Our discussions with the Trust have had little success. We have asked the Council to take enforcement action. We have met with Mike Holland, to talk about his plans for a new "family orientated" pier.

#### **Planning and Conservation**

We have continued to review planning applications in the area and to attend the Conservations Advisory Group. Our representative is Duncan Cameron.

We objected to plans to demolish the old stable buildings in Stone Street (formerly Hill Brothers' Builders). The application was withdrawn. We have applied for the buildings to be listed.

We also objected to the design of new flats in Stone Street. Approval has now been given but with a few changes which address some of our concerns.

The Council has applied for permission to make improvements to the Regency Square car park. We welcome much of the plan but we objected strongly to the proposed glass structure which would obscure views of the houses in the square. The application has been withdrawn for revision following numerous objections. We are currently discussing an alternative plan with Council officers

## **Keeping the Area Safe**

We have met Bobbi King, our local PCSO regularly.

The Council is planning improvements to street lighting across the city. We are discussing with Council officers possible changes in our area designed to reduce crime.

Rhidian Hughes was elected as secretary in 2006, a post he held for three years. He obtained a grant for the Society of £2,200 for a heritage board.

We are pleased that Julie White, who recently moved to the area, has agreed to be nominated for election as a member of the committee.

# **Treasurer's Report**

Apologies for the slightly longer summary of annual accounts this year. This is necessary because we currently have four separate funds.

Our General Fund shows a slight increase in income over last year (£892 compared to £875); the surplus of £316 is also up on the figure of £211 for last year.

The Russell Square Seat Fund is new. Following the sad death of long time resident Ken Kennar, we have received two donations, totalling £100 towards a bench in memory of Ken.

The Regency Square Improvement Fund has, this year, paid for some of the garden improvements agreed via the consultation questionnaire. We used a total of £1,508 to buy two new benches and start planting out the new flower bed.

Finally, the Heritage Board Fund shows no change this year as details of the board's installation have yet to be finalised.

Thank you for your subscriptions and donations, which have enabled us to continue RSAS activities on your behalf.
