
20 MPH CONSULTATIONS

The consultation has started for the 20mph speed limit and will last until 10th August. The City Council has already distributed 10,000 leaflets and survey forms to randomly selected business and homes across the City. Additionally, there will be exhibitions held at Brighton and Hove Town Halls in July, the consultation will be accessible through the Council's website Consultation Portal (http://consult.brighton-

hove.gov.uk/portal/bhcc/transport/20 mph/20 mph 1) and additional survey forms will be available from Hove Town Hall if required.

It should also be borne in mind that this is only the first stage of consultation and is in respect of the scheme in general; should the scheme progress, any changes to speed limits on specific roads would require a Traffic Regulation Order, which would have to be advertised and any objections properly considered.

DRAFT CITY PLAN

Brighton and Hove council have presented their plans for their vision for the future of the city. The committee have seen the plans; they have met with Jason Kitkat and will be sending in a report on behalf of the members of the society, setting out some views on the plan that will affect our area. Broadly the committee is in favour of the City Plan but would like to highlight that the plan could bring more people and more traffic which could negatively affect our area. We would want to be sure that new buildings proposed in our area will be designed by quality architects and that there is no further development on the seafront.

PRESTON STREET IMPROVEMENTS

Exciting improvements are about to start at the south and north ends of Preston Street. The council have approved £45,000 to lay granite paving slabs at the entrances to Preston Street similar to those in New Road. The works takes place on 23rd July. The south end will close whilst the works, which will take about 2-3 weeks; are carried out. The south end will then be re-openened and the north end will then close for the same length of time. Obviously there will be some disruptions whilst Preston Street is closed. Stone Street and Castle Street will be able to use Preston Street as a two-way street whilst the north end is closed. The traffic lights at the south west corner of Regency Square will be finished in time so that exiting left or right from the square will be possible.
