The Committee's Annual Report

Improving the area

As always, the year has seen some improvements achieved and others planned but not achieved. The bench in memory of long term resident Ken Kennar was installed in Russell Square and is being well used. The Regency Square Heritage Board is finally in place at the north end of the top garden and looks very impressive. There has been successful liaison with the Council to improve street lighting in the area over the year.

Work in progress includes having the large, superfluous sign above the car park removed and finding a way for the gates into Regency Square's top garden to be opened easily by everyone including wheelchair users, yet close behind people to shut dogs out. You may rest assured that we will pursue both to successful conclusions. Thanks particularly to Nigel Rose for liaising with the Council on these and many other environmental issues.

Communal recycling bins

We have had a number of meetings with the Council about how the scheme to replace individual collection of recycling with communal bins would work and the location of bins. Our understanding is that the scheme will definitely go ahead, but no start date has been given. The Council has been amenable to our suggestions for lessening the visual impact of the bins in our

Gardens

Hedges at the north ends of the middle and lower gardens in Regency Square will be planted in April to hide the concrete car park walls. Angelo Martinoli has very generously offered to sponsor this new planting. A composting scheme for private households, organised with Brighton and Hove Food Partnership and the Council is due to start in March. Also planned is the returfing of the south east area of Regency Square, which is still rather bald from the car park Portacabins.

The West Pier Site and the i360

The last few months have seen a dramatic development in this sorry tale. A proposal has been made for the Council to draw down a government loan of £36 million, which would enable the i360 project to go ahead. The decision to approve the loan was made at a meeting of the Council's Policy and Resources Committee on March 6th. Opinions vary on this decision. Some think that public money should not be risked in this way. Others believe that the potential benefits of the i360 to the city, and to our area in particular, are worth the risk involved. There are of course varying views on the i360 itself. These range from believing it to be a monstrosity to regarding it as an elegant contemporary design.

In the meantime Nigel Rose's efforts to persuade the West Pier Trust to tidy up the ever more derelict site have met with some success, as the Portacabin has been removed.

Planning, Housing and Conservation

Duncan Cameron has monitored planning applications throughout the year and has continued to represent us on the Conservation Advisory Council. Paula Brookes has taken a particular interest in Stone Street and Castle Street.

The year has been characterised by problematic planning issues which remain unresolved in spite of a great deal of work on the part of our local activists. The exterior of 67 Preston Street looks ever more decrepit and steps are underway to persuade the Council to issue an enforcement notice to the owner. An application to turn part of the building into a house of multiple occupation was rejected by the Council Planning Committee.

An application to turn 43 Russell Square from a family house into four small flats was also refused by the Planning Committee at a meeting at which Julie White put forward arguments on our behalf against the application. This decision is, however currently being challenged.

The application to build a 14 unit student hostel in Castle Street, which is opposed by 25 residents in the immediate area, is due to be considered shortly.

The lease for the properties occupied by the West Pier Project are due for renewal in 2015 and we have written to the Council arguing that Regency Square is not a suitable location for a hostel of this size and type..

The Campaign Against Antisocial Behaviour

Antisocial behaviour associated with alcohol and drug use has long been an issue in Regency Square, but the wonderful summer of 2013 meant that it became even more of a problem. The police responded really well to our frequent reports of groups of drinkers and rough sleepers. We believe that zero tolerance is the only way to disabuse those concerned of the idea that Regency Square is a place to come and get drunk, pick up drugs or camp.

We plan to put notices up for the summer around the Square stating that it is a no drinking zone and we are meeting shortly with the police to discuss future action. They have asked us all to report every incident of antisocial behaviour and we would urge you to do so (Phone 101 for non-emergency reports). Even if the perpetrators have gone before the police arrive, the call or email is logged, and collectively our reports make the case for more police resources to be directed towards the problem. We will publish further police contact details in future newsletters.

Newsletters and Social Events

Thanks to Suzanne Hinton and Julie White for producing the 10 newsletters which we have sent out this year. We have generally received good feedback about them and members seem to feel that they are an effective means of keeping in touch with what is going on.

Treasurer's Report

It was a pleasure to hand over cheques for £935.11 for the Russell Square bench and £2424 for the Regency Square

Heritage Board and to see these two enhancements to our area installed. We had to top up the £2200 heritage board grant with £224 from the Regency Square Improvement Fund as we opted for a more expensive (and hopefully more durable) material than was originally envisaged. The £100 donation from M&M Tours towards period street signs was returned once we realised that such signs would be far beyond our budget.

The Regency Square hoteliers generously agreed to leave the £170 they had donated for a Christmas tree in 2013 in a fund for the coming Christmas.

In spite of increases in some of our routine expenditure, particularly postage and insurance, we ended the year with an increase of £532 in our General Fund. Members agreeing to receive newsletters by email rather than post have helped to keep costs down. The fantastic prizes donated by local businesses at the 2013 AGM really boosted income from the raffle.

Many thanks for your subscriptions and donations, which have enabled us to carry on with the work of the RSAS over the year.
