## SQUARES, PLAIN; PRESTON STREET, PEARL?

Preston Street is lively and has some excellent restaurants. In December, the traders eschew banal Christmas symbols. They light the street with glowing red hot chilli peppers and shooting stars. They're great fun.

Preston Street is busy, bright and a bit brash. It attracts a range of people out to enjoy themselves. Perhaps those people are a little noisy, but they are all more or less in one place and have a common purpose.

The three squares in our area are subject to a pleasant, sober uniform painting scheme. The hotels and guest houses in the squares are where people come to sleep, whether they have been partying in West Street or trudging around the Pavilion or the museums all day.

The houses and flats in the squares are where people need to feel private and comfortable. They have chosen to live in a local square precisely because the squares are subdued and calm.

There are more and more commercial properties in the squares who are taking away the tranquil nature of those parts of the area. Many hotels are sporting garish floodlighting which negates the uniform painting scheme.

At least one bar has an unsightly banner strung across the full width of its Regency railing. Bars are allowing guests to congregate in the street - these guest are not necessarily rowdy, but a little street noise travels far and high on a quiet night.

### NOISE?

If you are being troubled by persistent street noise or noise from rowdy neighbours, the Society has some suggestions:

- ➤ if the noise is probably one-off and unbearable, a noise patrol operates from 10pm to 3am on Friday and Saturday nights to monitor and respond to noise problems affecting a large number of people. Phone (01273) 293541;
- ➤ If the noise is persistent or repeated but not urgent, contact Environmental Health at <a href="mailto:ehl.environmentalprotection@brighton-hove.gov.uk">ehl.environmentalprotection@brighton-hove.gov.uk</a> or phone them on **01273 292229**;
- ➤ keep an accurate diary of persistent noise. Note date and time, giving a very brief description of the noise disturbance. Several years ago Society members found such diaries crucial when bringing court action against rowdy elements in the area.

### **PLANNING**

**Kings Road Arches**: BT has applied to install a telecommunications cabinet on the lower promenade. The Society has no comment to make on this application.

**6 Stone Street:** Prior approval has been given to turn these offices into three flats. No full planning permission application has yet been lodged, but the Society would welcome new homes in the area.

**122 Kings Road**: The Society can find no planning application since 2007 for work which is now being carried out in Queensbury Mews to the rear of 122 Kings Road. This permission to raise another storey on the building has lapsed and is no longer valid.

On the one hand, it would be nice to have more residents in Queensbury Mews to provide more homes and to make the area more vibrant.

On the other hand the Society will keep a close eye on the development to ensure that any building work is sympathetic to the nearly properties, some of which predate the building of Regency Square.
