Planning applications

9 Clarence Gardens (The Little Theatre): Demolition of existing garage and erection of two storey rear extension and first floor front extension with revised access.

It is good to note that the Little Theatre is thriving. The Committee of the Society have two concerns:

- (a) the windows proposed on the south of the building will project and be very close to the rear windows of 7 Castle Mews;
- b) in the application, a proposed "directors box" appears to extend above the parapet of the facade in Clarence Gardens. This could cause both intrusive overlooking into houses in the Gardens and a considerable amount of additional light from the box when in use.
- **23A Preston Street:** Construction of an additional storey to create two additional bedrooms. Erection of a second and third floor rear extension.

In both Preston Street and Little Preston Street, this would give an acceptable stepped effect down from the four storey building to the north and the two storey building to the south.

60 Western Road (corner of Castle Street) Change of use of 1st and 2nd floors from retail to one 1-bed flat and two 2-bed flats with extension at second floor level.

The frontage on Western Road would remain virtually unaltered. However, the frontage on Castle Street will be increased in height and may look overwhelming.

135-6 Kings Road (West Beach Hotel): Erection of a single storey extension at fourth floor to proved eleven additional bedrooms.

All four applications have been discussed in detail by the Conservation Advisory Group who are experts in such matters and have advised the council accordingly.



Enforcement requests

22, 23 and 25 Regency Square: You've seen the dangerous-looking balcony propped up by a jack at No. 22, you've seen the dilapidated state of No. 23 and you've seen the incorrect colour of the window frames in No. 25.

The Society has requested that the City Council enforce the correct maintenance of these building which are an eyesore. In that top corner of the square, matters had been improving.

The owner of No. 20 has recently put a great deal of effort into making his property look spruce and an asset to the Square. Even No 21 (67 Preston Street) is no longer the derelict property it used to be.

In fairness to those property owners who make every effort to enhance the square, the Society looks to the City Council to enforce the rules that it imposes.

Imagine the surprise of the Society on being told that there was already an enforcement order against the white window frames of No. 25. And the date of that order? September 2014. The Council has simply not been able to do something as simple as to get a property owner to respect the Article 4 Direction which all the rest of us have to respect.

Floodlighting in Regency Square: The Society has reminded the planning department that the Council itself has already clearly established that floodlighting in Regency Square should be both of a neutral colour and subdued.
