Not so perfect in Clarence Square

Anti-social behaviour continues to blight Clarence Square despite the efforts of a stalwart of the square, Nigel Massey, and several other residents, supported by council officer, Simon Bannister. The locks on the gates supplied by the council are consistently and deliberately broken – by the same youth. His identity is known, but the police are unable to act without a very high level of concrete evidence. (photos etc) from witnesses.

The neglected state of the back entrances of the shops in Western Road seems to encourage other forms of antisocial behaviour. Gangs of youths match their behaviour to the state of the buildings. Heavy drinking and drug taking / dealing is common on the rear steps of the shops. This is accompanied by a high level of noise nuisance

The Council are finally about to install permanent signage restricting the opening hours of the park space to 9am to 6pm. However, volunteer residents who lock up in the evening are regularly harassed and abused while asking people to leave to allow the volunteers to lock up.

There is much that Society members can do:

1. If you see any signs of anti-social behaviour please, to support the residents of Clarence Square, contact the police immediately (2101 for non-urgent, 2999 if you believe a crime is being committed).

Even if police do not attend, the incident has to be logged by them. The more incidents that are logged, the more likely it is that police will become proactive to improve the situation.

2. Support any planning applications which plan to bring more residential property into existence above and behind the Western Road shops. This should make the square look more 'lived in' and less appealing to vandals, fly tippers and people littering (and worse).

Living in the city centre is a joy for most of us, but a few youths can turn that joy in to nightmare in some parts of our area.

i360 Security Shelter

The Society has received the following letter from Julia Barfield, joint architect of the i360:

"I write in response to your letter of 10th August in which you highlight your concerns regarding the installation of the security canopy and green screen arrangements.

"Can I begin by saying that the Society's support for the i360 project has been of great comfort to Marks Barfield since the early days of the project in 2005-6 to the current day.

"For clarity, it is worth re-counting a brief background history of this element of the project. In 2006, we were consented approval for two security canopies at the upper esplanade level to service each of the re-constructed Toll Booths in addition to a continuous glazed canopy which covered the queuing area.

"At that stage of the project it was envisaged that customers would be boarded through both Toll Booths with one catering for groups and VIP ticket buyers and the other for general ticketing.

"However, during 2014 the operational plan was firmed up and it was determined that all passengers would be boarded through the west Toll Booth only. At the same time, it was decided to utilise the eastern Toll Booth, and the boarding platform area to the south of it, for commercial use as a Tea Room.

"Therein the second canopy and queuing area had no purpose and we rightly decided to remove them from the building footprint.

"With regard to your comment regarding the ad hoc measures being put in place to provide the green screen can I say we wholeheartedly agree with your observations and re-assure you **that we are in the process of implementing a more fitting and permanent solution** which will complement the Toll Booth." Ms Barfield is correct in stating that there were originally two security canopies marked on the 2006 plans. These were of a simple, elegant 'butterfly' design. However, as late as October 2015 Ian Crockford, a director of Marks Barfield, wrote a very brief letter to the planning officer. This letter stated:

"I also attached the revised drawings for the security canopy as discussed which replaces the glazed roof version submitted. The canopy is a simple structure formed with louvred roof supported on 4no. columns the finishes in polyester powder coated aluminium cladding."

Despite two objections from the Regency Square Area Society in January 2017, this amendment was approved by the city council.

Given the huge number of conditions imposed upon the i360 relating to colour schemes, materials and heritage impact, it still seems that the i360 has spoiled the ship for a halfpenny of tar.

The only good news is that the detested green screen might soon disappear.
