## Anti-social behaviour - then and now

"James Andrews, 40, was charged with begging in the Kings Road. The Regency Square private constable said that about half-past eight on Monday evening prisoner solicited alms from him, and when refused money abused him very much. As the constable afterwards saw him go on to the Front and annoy a gentleman he informed P.C. Bingham, who subsequently took him into custody. Prisoner said he thought it was no crime, as he wanted food and lodging. He was sentenced to ten days hard labour." Brighton Gazette Thursday 23 July 1896

## Clarence Square

Youth Anti-social behaviour (ASB), Drugs and Child Sexual Exploitation (CSE). We are working with partner agencies to safeguard children and identify those responsible. We continue to patrol the area on a daily basis. You may see some tweets from the area. (@BtonHovePolice)

In our previous updates we explained what CSE is. CSE is never the child's fault, it is a crime that can affect any child anywhere, regardless of their social or ethnic background. CSE can be carried out by individuals, by street gangs or by groups. ## Planning

26-28 Clarence Square-noticeable by their three metal doors and derelict appearance. (48-50 Western Road) Plans to convert this property into 6 one-bed and 3 twobed flats was refused by the Council on 2 October 2017. The reason are interesting:
"The proposed dormers fronting Western Road, due to their design and prominent positioning, would unbalance the consistent and architecturally interesting roofline along this section of Western Road which would be highly visible within the streetscene. The proposal would therefore detract from, and cause harm to, the character and appearance of the existing building and the surrounding Regency Square Conservation Area.

The proposed development, in particular the rear
flats within the roof, by reason of their layout and lack of sufficient openings would not provide satisfactory accommodation for future occupiers in terms of outlook and levels of light. Furthermore in conjunction with the lack of outlook and light, the layout, size and sloping roofs within flats would form cramped and oppressive spaces."

As the Society is very keen to see these properties improved, the new application from the developers is welcomed. The main aspect of the new application relates to restricted space in the common areas.

There is a separate planning application for 26 Clarence Square relating to change of use from part of the retail space at 50 Western Road. This is in line with the council policy to reduce retail in favour of accommodation.

23 and 24 Clarence Square: A retrospective application for some aspects of the work already completed was approved on 10 October 2017. This property has improved greatly.

41Russell Square: Why have the residents of Russell Square been subjected to the clanging and flapping of the tin/plastic roof on No 41? A full planning application was needed to re-instate the roof. This was lodged on 4

September and still the council has not approved it. So the the people who live in No. 40, neighbours and others are all continuing to suffer noise and disturbance at the slightest hint of wind.

Clarence Gardens: The society has been assured by the Trustees of The Little Theatre that there will be no light pollution from the newly approved production box overlooking Clarnce Gardens. The Trustees state:

It will be essential that we have blackout blinds at the window when the production box is in use to shut out any external light. When the room isn't in use, the lights will be shut off.

The residents of Clarence Gardens welcome wholheartedly the development of the theatre now that that matter has been sucessfully resolved.
