

## **Planning**

**Former HMV store,** 60 Western Road BH2019/02505 Work is almost complete on the conversion of this property to a 20-bedroom House in Multiple Occupation. This work has no permission from the City Council.

The Society is fortunate in having the support of Cllr Tom Druitt who has objected directly to the Head of Planning, Liz Hobden on the grounds that the developers are riding roughshod over the planning process.

**Former HSBC Bank:** Western Road BH2019/02497 and BH2019/02496: Refused. A new application has been submitted, without the additional storey.

**26-27 Clarence Square** BH201900989 and 00991: You may have noticed that the historic railings on this property has been "vandalised" by the developers.

This is not the fault of the developers, but of the City Council. The original application by the developers shows good, traditional railings across the front of the property.

The City Council is insisting that the Council Tax paying future residents will have to have rubbish and refuse bins on the property, immediately outside their windows. This is despite the fact that there are communal rubbish and recycling bins within a few feet of the property.

In order for these large rubbish bins to be moved to the street and emptied, gaps have had to be torn through the railings.

The Society will be objecting most strongly to the City Council that they have forced the developers to damage an important aspect of this conservation area.

Why did the Society not object to this application? The application was filed under the address of '48-50 Western Road'. It's one the committee has to admit it missed seeing.

**How can you help?** If you are aware of any prospective development in the area and you are concerned about it, please let the committee know.
