At a recent committee meeting, the committee were delighted to welcome Regency Seafront PCSOs, Rebecca Lovell and Katie Bothwell.



# **Theatre in Regency Square**

Are there plans to put up a theatre tent in Regency Square during the 2020 Brighton Festival? This was the question that a group of Society committee members put to Ian Taylor, the Council's Events Manager at a meeting with him in November.

Ian explained that the City Council had temporarily lost several Festival venues due to the work on the Valley Garden Scheme. If the Council wishes to use Regency Square, Ian has promised to liaise with the Society in order to avoid some of the of the previous problems (Portaloos opposite residents' homes, a pay bar run by a non-local licensee etc) associated with the Roundabout Theatre tent a few year ago.

#### Planning

**26-27 Clarence Square** BH2019/00989 and 00991: On 11 October, the Society wrote to Liz Hobden, the Council's Head of Planning. The Society is objecting to the fact that the City Council obliged the developers of this property to put gaps in the heritage railings in front of these two houses. The letter made a formal complaint to the Planning Department.



The Committee was most disappointed that this complaint has been dismissed as irrelevant in an e-mail from the Customer Feedback Manager at the City Council.

The Committee is now seeking the support of local ward Councillor Tom Druitt who will be made aware of the misapplication of HE6 - Conservation Policies ie. the Council has treated this planning application as if the property was new-build whereas it should have been considered as an alteration to a historic building.

**37-39 Clarence Square**: BH2019/03016: Erection of an additional storey and conversion of first floor, part lower ground & ground floors to provide 4 one-bedroom flats, 2 two-bedroom flats and 1 three-bedroom flat including alterations to shopfront & revised fenestration to rear

Despite some reservations about the design expressed by the Conservation Advisory Group, the Society welcomes the upgrading of these properties. However, given the problems already experienced at No 28 Clarence Square, the Society has commented that heritage ironwork must be retained.

**45 Preston Street (formerly The Chequers pub)** BH2020/00076: Change of use of basement and ground floor licensed premises to part retail unit, and creation of residential unit.

The Society has no objection to change of use. However, the committee will be watchful in case any alteration is made to the bow windows at ground floor level. They may not be original to the building, but they do add variety and charm to the streetscape.

**65 Western Road** BH2019/03757 Part change of use & conversion of existing retail and retail space (KFC)) to form 3 self-contained flats. This includes the erection of a two-storey rear extension with access via Stone Street.

The property affected in 18 Stone Street is No. 18. The Society agrees with the comment made by the Heritage Department report: "the principal of the proposal is supported, however some details need finessing to lessen the impact on the character and appearance of the surrounding conservation area."

**Hotel Metropole:** The Society is leading a small group of interested local residents which has already met with representatives of First Base, the company that is advising the owners of the whole Metropole site. There are no specific plans for the site as yet, but there will be further meetings in 2020 ... and who knows, in 2021.
